GENERAL INFORMATION FOR SERVING GAMES

GAME CHAIRMEN: The food chairperson (Brittany Juliuson for Hope games (701) 866-6534, and Daisy Bergfield for Page games (651)253-3107: They will call you with how much BBQ/taco meat to make. First, call all your workers to remind them of their upcoming shift and the bars/pies they need to donate. Then call the store (Page or Hope) ahead of time to tell them how much hamburger you will need to prepare for BBQ and Taco meat. You can charge the hamburger and the ingredients you will be using for the meats to the School Parents. All other supplies and food will be at the school unless the Food Chairman contacts you ahead of time. Cash boxes will be at the school office, so return it there afterwards unless you find out differently. Remember to stay until everything is clean and put away.

TIME: Please have food ready to serve at 6:30pm for Varsity FB games. Check BBall and VB game time and please be ready to serve ½ hour before the start of the first game. If the game night includes a Freshmen (C) or JV game, pop and popcorn can be ready early but the rest of the menu doesn't have to be ready until 5:00 pm. Try to be there by 3:30/4:00PM to start the potatoes. There will be a form for you to fill out what is leftover, what you ran out of, etc. Please fill this form out.

MENUS: Jr. High games: concessions including popcorn, pop, candy and water. Varsity Football: Hamburgers, taco in a bag, hot dogs, baked potatoes, pie, bars, milk, hot chocolate, coffee plus concessions of popcorn, pop, candy and water. Volleyball and Basketball: BBQ, taco in a bag, hot dogs, nachos, baked potato, pie, bars, milk, coffee, plus concessions of popcorn, pop, candy and water.

HOPE SITE SUPPLIES: Two moveable cupboards with supplies and the popcorn machine are kept in the old weight room (located across from the boys and girls restrooms on east side). The keys for the cupboards are in the cash box (also in office). One cupboard has concession supplies to be set up in the lunchroom, the other has kitchen supplies. Check for leftover meat from previous games in the freezer as well as cheese, hot dogs and other food items. Items left in the school cooler or freezer need to be marked 'School Parents'. There are Ziploc bags to store leftovers in the freezer. Jr. High concessions can be set up in the hallway by the kitchen for football and by the office for basketball/volleyball.

PAGE SITE SUPPLIES: Ketchup and mustard are kept in the refrigerator and are labeled School Parents. Other supplies are in the School Parents cupboard located under the serving counter across from the stoves or on the School Parents shelf in the storeroom.

BEVERAGES: **HOPE-** the 100 cup coffee pot is for the hot water for hot chocolate, and needs one hour to perk. Use the 12 cup coffee pot for coffee. **PAGE-** use the 12-cup coffee maker. It's on the counter in the kitchen. Coffee/filters are in cupboard underneath. **BOTH SITES-** record the number of milks sold from lunchroom cooler on paper in cash box.

BARS: People furnishing bars... please plan to bring a large 11x17 pan, OR **(2)** 9x13 pans. You can order bars from Sarah's M&M Grocery **AT YOUR OWN EXPENSE**, do not charge them to the School Parents. *Please cut the bars to a reasonable size.*

PIES: 8" pies are cut into 6 pieces, 9" or 10" pies are cut into 8 pieces. You can order pies from the Page Café **AT YOUR OWN EXPENSE**, if you give them a few days notice.

BBQ's: You can use this recipe or any you like. Serve on paper plates/boats, using the BBQ scoop in the School Parent's drawer. Use a liner in the crock pot. DO NOT mix new meat with meat that has been thawed! Leftover thawed BBQ meat cannot be refrozen.

5# Hamburger; 5 T. mustard; 5 t. Worcestershire Sauce; 2 ½ cups of Ketchup; 1 ½ cups water; 5 T. vinegar; 5 T. sugar; with onion, salt, pepper, and liquid smoke to taste.

HOT DOGS: PAGE - There is a hot dog cooker in the School Parents shelf, chairmen are asked to use the cooker at all games. HOPE – (Football games) Cook burgers and hot dogs on the outdoor BBQ grill. Make sure only adults are using the grill!

NACHOS: (PAGE SITE ONLY) Start early as they sell right away. If you are short on time, heat the cheese in the microwave before putting in the crock pot. Each large can serves 50 and use 2oz individual bags of chips. Please use a liner bag in the crock pot.

TACO IN A BAG: Use taco meat made by chairperson. Workers at the school will need to chop tomatoes, lettuce, onions, slice black olives (sometimes have cans of sliced olives). Shredded cheese is in Parents' fridge. Use a liner in the crock pot. DO NOT mix new meat with thawed taco meat!

CONCESSIONS: Two or three parents should be in charge. Come early to pop the popcorn before the first game. Instructions are on the machine.

BAKED POTATOES: Chairmen wrap and bake potatoes (**about 20**) for 1 ½ hours at 350 degrees. Set out butter, sour cream and bacon bits.

CONDIMENTS: Set out on the table in cafeteria: tomatoes, onions, sour cream, black olives, taco sauce, bacon bits and butter.

CLEAN UP: Please leave the kitchen clean!! After sweeping the floor, please wipe up spills if needed. Sweep the entire lunch room and wipe the tables off. The garbage should be put in the dumpster outside. All pans should be returned to the owners, do not leave them in the kitchen. Food items put in the freezer/cooler should be marked 'School Parents'. **HOPE-** When you are done serving, put all of the non-refrigerated supplies back in the cupboards, lock them, and return the key to the cash box. Push the cupboards and popcorn machine back into old weight room.

FOOTBALL BBQ GRILL CLEAN-UP: Be sure to empty the grease cup below the grill before moving the grill back into storage.

CASH BOX: Pick up at office prior to serving. Make checks out to HP School Parents. If the treasurer isn't at the game, please return cash boxes to the office. Please don't accept pop bottle caps as payment. There is a notebook in the Page cash box to mark down the number of milks sold.

*There is no charge when workers eat as long as it is within reason.
